The Parties to this Deed are:

(1) **The Secretary of State for Education** of Sanctuary Buildings, Great Smith Street, London SW1P 3BT (the "**Secretary of State**");

(2) **TONBRIDGE GRAMMAR SCHOOL**, a charitable company incorporated in England and Wales with registered company number 07455728 whose registered address is at Tonbridge Grammar School, Deakin Leas, Tonbridge, Kent, TN9 2JR (the "**Company**").

together referred to as the "**Parties**".

INTRODUCTION

- A. The Parties have entered into a funding agreement on 22 December 2010 which was further varied by a Deed of Variation dated 19 May 2015, a copy of which is contained in Schedule a, (the "**Existing FA**").

The Secretary of State and the Company agree that with effect from the date of this Deed, the Existing FA shall be amended and re-stated in the form of the Funding Agreement set out in Schedule b (the "**Amended Funding Agreement**"). For the avoidance of doubt, the Amended Funding Agreement does not terminate or suspend the Existing FA but amends and re-states it.

- 4. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of,

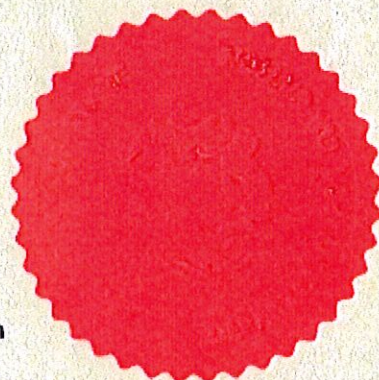
or in connection with, this deed or its subject matter or formation (including non-contractual disputes or claims).


